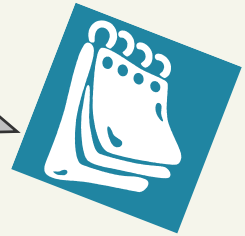

As 2017 comes to a close we want to take the opportunity to "Thank You" for being a valued customer. We are proud to be a trusted partner and to help you with your insurance needs.

There are some coverages we would like you to consider adding to your Homeowner's policy: Inland Flood, Service Line and Identity Fraud Theft.

Inland Flood coverage is currently only being offered by Millville Mutual but more companies, such as Donegal, may add this coverage in the future. This endorsement is designed for residents in lower flood risk areas. It covers the residence, personal property in the basement,

debris removal and loss of use, some of these coverages are excluded by the National Flood Program.

Service Line coverage can also be added by endorsement to your homeowner's policy. This is for coverage of replacing/repairing underground service lines-such as water, sewer, electric, cable, gas and telephone lines that fall under the property owner's responsibility. It is typically less expensive to add this coverage to your homeowner's policy then to purchase it from your utility provider.

Identity Fraud Theft can be added to most homeowner policies by endorsement. This cover-

age reimburses victims for expenses they incur to correct their credit or identity records.

PRIVACY POLICY

Snyder-Eyster Agency, Inc. (Snyder-Eyster) collects information about our customers (Sometimes referred to as Non-public Personal Information) that is necessary to provide those services usual to independent insurance agents. We receive this information from you on applications, which may include names and addresses and birth dates and social security numbers. We maintain clients' transactions, such as claim and payment history. Additionally we receive information about you from consumer reporting agencies, which may include driving records and insurance credit score reports, comprehensive loss underwriting reports. This information is important to the acceptability and pricing of the quote, renewal or policy being requested. Once a policy is written we have access to other sensitive information such as mortgagee holders, holders of certificates of insurance, claim information and police reports. This information is necessary to the normal conduct of insurance business among customer, company and agent.

Snyder-Eyster may use this information to obtain alternate quotes, known as "shop around" within the family of companies that we as an independent agent represent or have access. In other words we are looking for a "better deal" for our customer without express permission, although we assume we have your implied permission.

Additionally, Snyder-Eyster will share this information if required by law, such as subpoena, or to protect or prevent fraud, unauthorized transactions, claims or other liability.

Other than the incidental use described above, Snyder-Eyster never has nor does it intend to share your Non-public Personal Information with non-affiliated third parties. We do not sell customer lists to anyone.

Our agency has in place an Information Security Program (effective 10/20/05) designed to guard the confidentiality and security of your information. We have *Administrative Safeguards* detailing how our employees handle your information; *Physical Safeguards*, detailing the security of the office premise and *Technical Safeguards*, such as anti-virus/anti-spyware software and external backup drives installed to our computer network.
